

Terms and Conditions

- 1) Information on how to enter and prizes form part of the Terms and Conditions of Entry. Participating in this promotion is deemed acceptance of these Terms and Conditions of Entry.
- 2) Entry is open to Australian residents who attend the Sydney Motorcycle & Scooter Show, 25 – 27 November 2011. Employees of the Promoter and/or the prize suppliers, Cape York Motorcycle Adventures and their immediate families and agencies associated with this promotion are ineligible to enter.
- 3) Upon purchasing an entry ticket to the show, visitors will have the right to enter the Sydney Motorcycle & Scooter Show Major Prize by visiting the entry area on stand 264A inside the Show and filling out their name, phone number and email address on an Ipad provided by the Promoter. Visitors are limited to one entry per person.
- 4) The promotion commences on Friday 25th November 2011 (10am EDST) and the promotion closes on Sunday 27th November 2011 (230pm EDST). All entries must be received by 230pm Sunday 27th November 2011. The prize will be drawn 3pm EDST Sunday 27th November 2011, at the QBE Stage (main stage) at the Sydney Motorcycle & Scooter Show, Sydney Convention and Exhibition Centre, Darling Drive, Darling Harbour, NSW 2000. The winners names will be read out to the crowd. The winners will then be contacted via phone and in writing via email.
